GEORGE JAMIESON FARM

The farm is situated on North 1/2 of Lot 24, Concession 4 Aldborough Township, consisting of 100 acres.

The ownership passed from the Crown to Robert Jamieson in 1856 and then to his son, George A. Jamieson approximately 1890. In 1930, it was passed on to J. Roy Jamieson and then, in 1950, it was deeded to George A. Jamieson.

There have been three houses on the farm, the first one being a log house, then a frame house built with 1"x6" laid on its flat and plastered on both sides then covered with tin. The present house was built in 1911.

THE STEWART FARM

The farm is situated on the North Half Lot 2, Concession 2, Dunwich township.

FARHLY

Laird (John) Montgomery Farm, now the Jack Gilchrist home farm. 100 acres, Lot 2, south half of Concession 3 (Dunwich) Maggie, Jessie, Bill, Gory were born on this farm.

Farm at end of Concession Two Dunwich owned by Jim and George Tait, 100 acres, South half of Lot 1 Concession 1 (Dunwich)
The house which stood on the property on farm owned by Jim and George Tait was formerly owned by Neil McEachren; Dave Stewart, Peter D. McCallum were the last people to live in it. Frame two storey house. Family born there were Johm, Cochrane and Archie McCallum.

Property owned by Duncan Tait in Aldborough Township, the east half of the southeast quarter of Lot 2h in the First Concession, purchased from Belle (Green) Stalker in 1963.

This property of 25 acres had been willed by Neil McGill to Belle Stalker, his niece, in 1940.

The buildings of a small house and barn were built after the purchase by Neil McGill.

Previous owners were Neil McGill, Duncan Campbell in 1900 and John Munro in 1872, George Campbell, Geddes, Gilkinson, Grant and the purchase from the Crown in Sept. 1, 1797.

Philip McCallum - north half Lot 3 Concession 2 (Dunwich) 100 acres.

THE McEACHREN FARM

The North half of Lot 1, Concession 3, Dunwich Township, Elgin County is the John McEachren farm. It was cleared by Mr. John Dobie. He sold it to Mr. Daniel Finlayson, who resold to Finlay McEachren about 1882. His son, Mr. John McEachren, is the present owner and still lives on it.

THE McCALLUM FARM

The McCallum farm is situated on Lot 3, Concession 2, Dunwich township. It was a Grown sale grant to John Hugh Munroe on June 13th, 1873. Mr. Munroe sold to Donald Crawford on October 24th, 1874, who in turn sold to Peter D. McCallum on April 27th, 1882. His son (Finlay) Philip McCallum, who took it over on August 3rd, 1933, still resides there in the year 1953.

HISTORY OF THE CARMICHAEL FARM

The Carmichael farm is located on Lots 18, Concessions A and B. Aldborough Township, Elgin County. Papers describe

it's history as follows:

Will by Alexander Grant of Amherstburg, District of Upper Canada, member of Legislative Council and Executive Council, who had been given a large grant of land in Upper Canada. including a valuable farm at Grosse Point. The will, which was made out in 1811, bequeaths 500 acres of land as well as 1/8 of his money to his daughter Rabella, wife of William Gilkinson, who had a large family.

January 1846 - Alexander Grant Gilkinson, Glasgow, Scotland, 2. sold 50 acres of land to Amos Thomas, Aldborough, in Middlesex County. District of London, for 100 Pounds through an agent

Andrew Geddes.

May 14. 1853 - Amos Thomas sold this land to Amasa Thomas, 3. son, for 25 pounds. 1860-1864: Amasa Thomas bought 23 acres from John and Margaret Mulligan.

June 30, 1869 - Amasa Thomas and wife Jane sold farm to

Anson Thomas.

January 10. 1874 - Anson Thomas sold farm to Thomas Gilbert for \$2500.

June 3, 1882 - Thomas Gilbert sold farm to John Trestain for 6. \$2000. Duncan D. Campbell took mortgage for \$2000 at 9% interest.

October 4. 1889 - John Trestain sold to John A. Trestain.son. 7. for \$4000.

October 4, 1892 - John A. Trestain sold to Walter Scott Tait 8.

for \$3000, with mortgage of \$1500.

Walter Scott Tait sold to William J. Webster and wife Kate. 9.

10. William Webster sold to Duncan J. Campbell. bachelor. on December 15, 1906, for \$3500.

11. Duncan J. Campbell sold to Arthur Martin, October 15, 1908.

12. Arthur Martin sold to James Carmichael, February 5, 1920.

13. Archie Carmichael's father died without a will. In 1943, Archie paid the 4 brothers and 4 sisters their shares, and got deeds from them. making him sole owner.

ARCHIE CAMPBELL FARM

The farm is situated on the Townline, Lots 1 and 2, broken front, Dunwich Township. This farm, where Archibald Campbell lived, was bought in 1853 from a land speculator, by the name of Mr. Gordon, when it was an unbroken forest. It was in the family possession until 1953, when it was sold to Clair Dymock.

THE CARROLL FARMS

North of Lot Y, Concession 1, consisting of 100 acres, was first owned by William McDonald. Then it was owned by John McDonald, his younger half-brother, who built a small barn and later, about 1891, the brick house now standing.

The present owner, George M. Carroll, bought it in 1915. He moved and enlarged the barn in 1920.

The South-east \(\frac{1}{4}\) of Lot X, Concession A, consisting of 50 acres, was owned by McLeans, then Jamiesons, and in 1934 was bought by the Carrolls.

JOHN D. CAMPBELL'S FARM

The farm is situated on the West $\frac{1}{2}$ of Lot Y, Concession 2. The ownership passed from the Crown to Richard Airey, then to Donald McGill in 1869, then to Duncan Campbell, then to John D. Campbell in 1904, and is now owned by John L. McKillop who bought it in 1954.
