



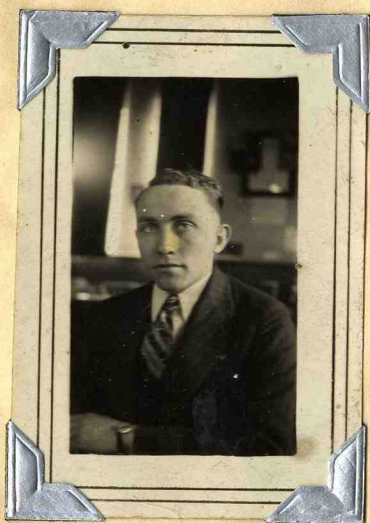

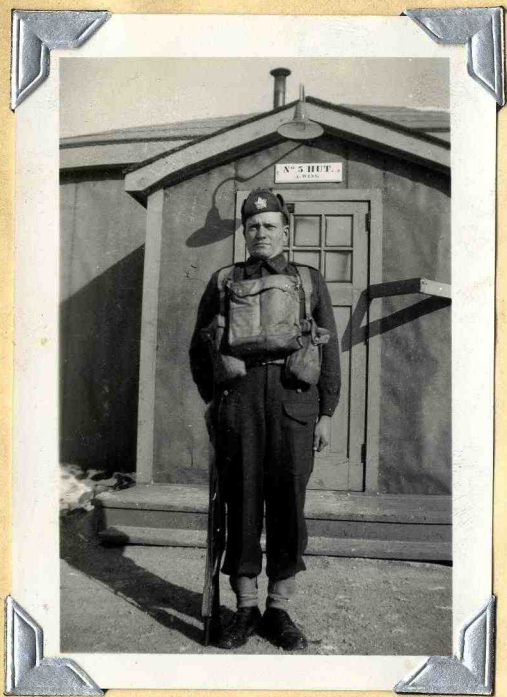

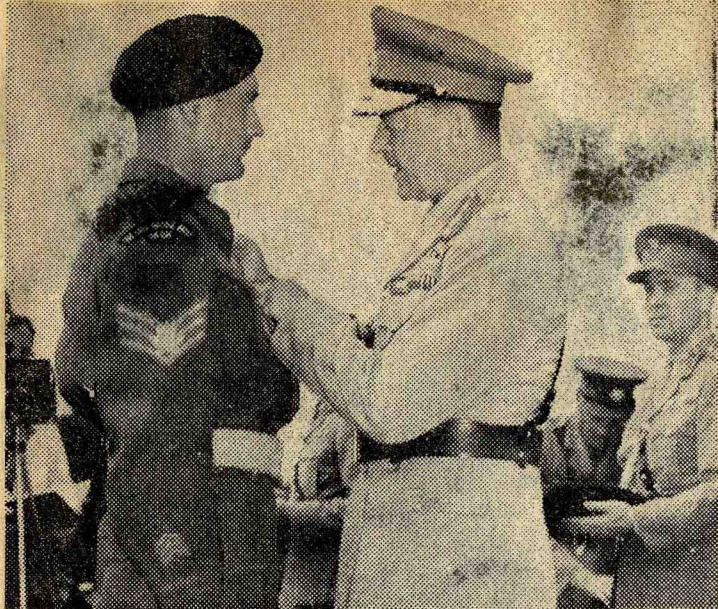

**HONORED FOR EXCEPTIONAL SERVICE** while attached to an armored car section during fighting in North-West Europe, Sgt. Bruce McKay Stalker, native of Rodney, was awarded the Military Medal at a special investiture held recently by Viscount Alexander, Governor-General of Canada, in Windsor. In the above photo, Viscount Alexander is shown pinning the award to the soldier's tunic. The citation stated that "at all times Sgt. Stalker showed the highest order of leadership, initiative and daring."

Sgt. Bruce Stalker, son of Mr. William S. and the late Mrs. Stalker, enlisted on June 28th 1942, and served in the Army-armoured Corps.

He was three years and seven months in the Service and served in England and North-west Europe.

Sgt. George Jamieson, son of Mr. & Mrs. Roy Jamieson enlisted on March 20th, 1941, in the R. C. O. C, and R. C. E. M. E. He was from March 20th 1941 until Januray 10th, 1946 in the service, serving in Canada.

Tpr. William J. Cook, son of Mr. & Mrs. Charles Cook, enlisted with the Active Army on Sept. 19th, 1939, in the First Hussars and served eight months at London, Ontario, at Camp Borden for one year, at Kingston for two months and Toronto for two months before being discharged on Sept, 22, 1941.

Spr. John D. McCallum, son of Mr. & Mrs. D. D. McCallum, enlisted in August 1942, in the R. C. E. He was three years two months in service, and served in Canada, England, France Belgium and Holland.

Pte. Ed. McCallum, son of Mr. & Mrs. D. D. McCallum, enlisted in September 1942, in R.C.A.S.C. He was three years in the service and served in Canada, England, North Africa, Sicily, Italy, France, Belgium, Holland and Germany.

Spr. Leslie Harold Johnston, son of Mr. & Mrs. George Johnston, was born in Dunwich. He joined the Royal Canadian Engineers in London, Ontario, July 1942, enlisting for general service in October 28th, 1942. He served in Canada, until February 28th, 1944, when he went to the United Kingdom and was on duty in England until crossing to France on "D" day on July 8th, 1944. Spr. Johnston was reported missing while serving in France with the 18th Field Company R. C. E, and was presumed dead on March 27th 1945. He was believed to have been killed in action on the 8th of July, 1944 in the vicinity of Villons Les Buissons, France.

Pte. William Edward Evans, Born in Liverpool, England on August 29th, 1906. He joined the R. C. A. M. C. in January 1943, and enlisted for active service in April 1945. He took training at Sherbrooke, Quebec, and Camp Borden and Nova Scotia.

Major John Norman McEachren, son of Mr. & Mrs. Neil McEachren, was born on September 8th, 1905. He enlisted with the 1st U. S. Army, 45th Evacuation Hospital on May 29th, 1942. After serving fourteen months in the United States he went to the United Kingdom and after seven months duty there, crossed into France where he served for three months. Later he spent seven months in Belgium and seven and a half months in Germany. He returned home to Fairport, New York, and was discharged on October 3rd, 1945.

Robert Alexander McAlpine, Able Seaman, son of Mrs. M.A. McAlpine and the late Mr. McAlpine, was born in Dunwich, May 29, 1923. He enlisted in the Royal Canadian Naval Volunteer Reserve at Hamilton on October 15th, 1942, and was called to active service April 4th 1943. He trained ashore in Canada at Hamilton and Cornwallis, Nova Scotia, before seeing much service overseas in the United Kingdom. While on board H.M.C. S. "Prescott", a Canadian Corvette. During this service he participated in "D" Day operations. After several months in Newfoundland, Bob was discharged November 2nd, 1945.

Lieut. Nursing Sister Doris (Godley) Norris, daughter of Mr. & Mrs. Harry Godley. She enlisted on the 25th of April, 1942 for South African Medical Nursing Service. She was discharged on August 20th, 1943, and enlisted again on November 25th, 1943 with the Royal Canadian Army Medical Corp., and saw Service in England and France, and her total Service was three years and one month.

Private Duncan Tait, son of Mr. & Mrs. Thos Tait enlisted on March 20th, 1941 in the Royal Canadian Ordinance Corps. Length of Service from March 20th, 1941 until January 21st, 1946. He Served three years overseas, serving in the campaign on the European Continent.

Capt. Finlay Stewart, son of Mr. & Mrs. Duncan Stewart, born in 1908. He was a padre in C. B. Ordinance Work Shop in England one year. He served in the R. C. E. M. E. in France, Belgium, Holland and Germany till the end of the war.

L.A.C. Archibald McGill, son of Mr. & Mrs. J. J. McGill enlisted on Sept. 25th 1942, in the R.C.A.F. He was  $2\frac{1}{2}$  years in the service in Canada.

Pte John J. Watson, son of Mr. & Mrs. John R. Watson enlisted on July 26th, 1940, in the Infantry. He was five years four months in the service, and served in England, Holland, France, Germany also in the Mediterranean and Italy.

Gunner Geo. Cook, son of Mr. & Mrs. Charles Cook, enlisted in the 14th Fld. Reg't. R.C.A. on February 11th, 1943. He was three years in the service and served in Canada and United Kingdom and European theatre,

Corporal Albert Cook, son of Mr. & Mrs. Charles Cook, enlisted on Sept. 18th 1939, in the First Hussars, 6th Armoured Reg't. He was six years in the service, and served in Canada, United Kingdom and Continental Europe, and was wounded on "D" day.

William Morley Frank, son of Mr. & Mrs. W. D. Frank, enlisted on August 3rd, 1940, in the R. C. A. F. He was four years six months in the service, and served in Canada and England.

Jack Elwin Frank, son of Mr. & Mrs. W. D. Frank, enlisted in August 1942, in the R.C.A.F. He was three years in service in Canada.



Pte. Ivan Matheson, son of Mr. & Mrs. J. A. Matheson enlisted in Sept, 1939 in the Essex Scottish. He went overseas in July, 1940, and was killed on November 14th, 1944 in Holland. He served in England, France and Holland.

Verne Frank, son of Mr. & Mrs. Will Frank, enlisted on February 4th, 1942 in the 2nd Division. He was promoted from Bombadier to Class B. Tradesman. He served in Canada, Germany, and Holland, and was discharged on March 14th, 1946. He was a little over one year overseas.

Pte. D. B. McColl, son of the late Mr. & Mrs. D. B. McColl, enlisted in September 1939, in M.D. 1, London. He was six years in the service, and served in France, Italy and Africa.

Pte. Archibald Frank McLarty, son of Mr. & Mrs. Frank McLarty, was enrolled in the N.R. M. A. at Chatham, December 4th, 1941 for two months. Basic Training, From there he went to Camp Borden, Training Camp for two months. He was then sent to New Westminster, B.C., and North Vancouver. After six months he was granted a compassionate leave which he held until his discharge on October 18th, 1945.
