ABRAM NELSON GRAY
Oct. 3, 1854 - Sept. 1, 1945

Mr. Abram Nelson Gray, son of Edwin and Hannah Gray of Eden, was Sunday School teacher, singer Superintendent, Deacon, Church Clerk and Choir leader as well as school trustee at Eden. He superintended the building of the Eden Church, drove stage for a time, post office in Ingersoll, worked for Harris & Co. of Tyrconnell, farm machinery sales.

He married Jenny Allemand, eldest daughter of Fred Allemand and they had two daughters and two sons.

He was registrar at Woodstock College, later moved to Alberta where he managed a 4000 acre ranch. He bought his own land and eventually sold out and moved to Vancouver where he died at the age of 90 on Sept. 1, 1945. He continued in good health taking daily walks until the day before his death. He left his wife, daughter Mrs. Alex Wilson (Grace), Mrs. E. J. Gray, one brother Nathan of Eden, three grandchildren. His ashes were buried in Eden cemetery on Oct. 27, 1945.

V. Evan Gray

An authority on Insurance Law, Mr. V. Evan Gray died yesterday at his home, 32 Eastbourne Ave., after a brief illness. Mr. Gray served as assistant Income Tax Commissioner at Ottawa from 1918-20 and for the following four years was Superintendent of insurance & registrar of loan corporations for Ontario.

He was instrumental in bringing about the reform of provincial statutes to establish uniformity of insurance laws in all the common law provinces of Canada. Mr. Gray appeared before the Privy Council in the insurance constitutional jurisdiction references of 1923-1931, and in the Grand Trunk stock holders appeal of 1935.

Mr. Gray was keenly interested in the recent Dominion - Provincial conferences on constitutional amendment and advocated the election of a constituent assembly to write a new constitution for Canada.

Born at Tillsonburg he attended Norwich High School & Woodstock Collegiate. He graduated from McMaster University in arts in 1911 and two years later received his master's degree in constitutional history. He continued his studies in Constitutional law while carrying on an active legal practice. Graduating from Osgoode Hall in 1914, he was called to the Bar of Ontario. He received the degree of LLB from the University of Toronto in 1915 and was created a K.C. in 1933.

During the past year Mr. Gray had lectured in insurance law at University of Toronto School of Law. He was an active member of the United Nations Association.

He was an active member of Yorkshire Baptist Church and also a member of the Canadian National Committee on Refugees and the Canadian Institute of International Affairs. He was formerly on the Board of Governors and Senate of McMaster University.

Mr. Gray was the author of Canadian Constitutional Development Since Confederation and a co-editor of Canadian Insurance Case Law & Insurance Law Reporter. He was also the writer of numerous published articles. His most recent article on insurance legislation which was published in the May, 1950 issue of the CANADIAN BAR REVIEW was reprinted in the Insurance Law Journal in the United States.

He leaves his wife, Ruth Gray and three daughters, Ruth, Joan and Elizabeth.

DAWSON D. HEALY

Dawson D. Healy is of Irish and French extraction and was born at Annapolis, Nova Scotia, in 1848. He removed with his parents, when seven years of age, to the Township of Dereham on the townline of Bayham, and in 1889 he purchased a farm on the 9th concession of Bayham at Eden.

Three years ago, he disposed of this farm, lived a year in Woodstock and then purchased a farm of seventy-five acres on the townline of Bayham and Middleton, a mile and a half from Eden and near the Acacia cheese factory.

He was educated at the public schools and Clinton High School, and was successful in following the trade of cheesemaking for eighteen years until compelled to give it up fifteen years ago on account of ill health. Among the factories of which he had charge were Waterford, Clinton, Varna, Firby and Simcoe.

He is a Conservative in politics, though not extreme in his views, and a member of the Baptist church at Eden.

He was married in October, 1875, to Miss Permelia Ford, daughter of James Ford of Eden. The family of Mr. and Mrs. Healy consists of two sons and a daughter, Delamere D., stock broker, Toronto; Lloyd, student at Tillsonburg High School, and Miss Agnes, at home. She retired from the teaching profession at the end of last year, after having taught three years at Eden and three at Harrington, county of Oxford.

Mr. Healy is a member of several fraternal societies, the Independent Order of Foresters, the A.O.U.W., the Canadian Order of the Woodsmen of the World, and the Masonic Order. He has held the positions of Master Workman and financier in the A.O.U.W.
