James (Jr.) was given a farm at Strathroy by his father. He married Jane Heard and six children were born to the union, Newman, Lizzie, Annie, Bert, Lily and Emma. Anne married Thomas Gadsby, bearing him one child, Frank. She died in 1855, aged only 20 years, and was the second one to be buried in the family plot in the St. Thomas cemetery. Little Maria, who had died of dysentery in 1844 at the age of 9 months, had been the first to be buried there. William married Mary Jane Axford, staying on the home farm. Three children were born to them. Anna, William and Lila. George received a 50 acre farm at West Lorne. He married Lucinda Hodge. They had no children. He became something of a local preacher, and his home, a gathering place for ministers. Jasper went to California, from where it was reported, he had died. Noah married Louisa Allen and went into the real estate business in West Lorne. Louisa died in 1886 at the age of only 22, and was buried in the St. Thomas cemetery. Noah married again, to Lila Chute, and one child was born to them, a girl, Georgina. Harriet married James Mc. Nally, a cooper of Aylmer. After the death of her husband, she married James Drake of Kincardine.

In the Summer of 1862, Elizabeth (Sr.), overheated from the exertion of a walk to St. Thomas and back, suffered a stroke. It was thought that a drink of very cold water she took on her return, might have brought it about. For fourteen years, until her death on October 18th, 1876, she continued in poor health. She was buried in the family plot in the St. Thomas cemetery.

Mary Jane, wife of William, succeeded to the management of the house. As he grew older, James became more and more the country squire. In immaculate white trousers, he tended the flowers in his garden, or chatted long hours over a mug of cider with his friend and neighbor, Silas Toles.

On the Sabbath he made an impressive figure. Carefully attired, and with a black leather cane, with his heavy mane of snow-white hair and face clean-shaven save for a jaw-line fringe, he drove the trim phaeton into St.Thomas. His clear, somewhat piercing eyes had witnessed a significant era of development. During his lifetime, in his adopted country, he had watched St.Thomas grow from village to town. He had seen the log buildings give way to frame and later, to imposing brick edifices. The roads had been changed and straightened, from the axle-deep mud of the 1830's, through the corduroy roads to the good gravel thoroughfares, bringing with them the toll-gates. The first railway engine had puffed into the little town. heralding an era which was to give it the name of the 'Railway City'.

In April, 1885, an old man and full of years, he was gathered to his fathers, and laid to rest beside his wife in the St. Thomas cemetery. The immediate cause of his death was an attack of pneumonia. To his third son William, he bequeathed the farm.

William was a man of serene and tranquil mind. He lived a lifetime of quiet contentment such as is no longer possible in the complex world of to-day. Save for one trip to the West, and the yearly deer-hunting trips north, which he continued till he was well on into his 80's, William was rarely, during his lifetime, long absent from the farm. It was there he was born, and there, 86 years later, he died.

A fifth generation, whose greatest pleasure is to visit their grandmother and grandfather at the farm, has now arisen. There is another James
and Elizabeth, and in order of age, a William, Kenneth, John and Michael.

Very often now, they can be seen at play along the creek where James Dodd
took that first walk, or roaming the familiar hillsides. In season they
gather fruit from the gnarled old trees, planted more than a century ago
by the hand of a long-vanished ancestor.

## THE HISTORY OF THE WEINER FARM

The Inn situated about half-way between St. Thomas and Port Stanley and familiarly known as 'The Half-way House' or 'The Dutchman's Tavern' was built in the years 1843-44 by Henry Widdifield at the time the plank road was built from Port Stanley to London. For many years after the famous old road was in operation, (the only means of transportation between these two busy terminals), the rambling old tavern did a thriving business and many interesting tales were locked up in it's weather beaten walls. Charles Weiner became the owner of this famous old landmark when he bought the farm on which it was located on April 25th, 1870; and was it's genial proprietor for many years. At his death, his wife conducted the business and later their son, Charles . In the year 1918 the building was completely destroyed by fire, Mr. Charles Weiner and his family moving into the old stone house south of the hotel site, this quaint dwelling having been built by Henry Widdifield at the time the hotel was erected. Frank Weiner is the grand-son of Charles Weiner, Sr., he and his family now living in this house, he being the present owner of this fine farm.

The first log school house in S. S. No. I7, Yarmouth was built in the year I849, a quarter of an acre of land being bought from Henry Widdifield for a school site, which was on the north west corner of Lot 4, Con. 5. (On the corner of Con.5 and the Gravel Road) - this now being the F. Weiner property. This school was replaced by a one-roomed brick structure built in I88I which stood on the Todd farm, directly across the road from the fine new buff brick two roomed school on the west side of Highway No. 4. Mr. and Mrs.Sebastian Egner (Mrs.Egner being a sister of Mrs.C.Weiner, Sr.) lived in the cottage near the corner of the Weiner farm, Mr.Egner being a Shoemaker. They always grew quantities of

beautiful flowers in their garden, and more than one busy housewife of the district, recalls stopping at the Cobbler's shop on their way to and from school, to leave the family's shoes to be mended.

Francis Geo. Jones bought an acre of land in I849 and another one-half acre in I858, being part of the south-west portion of the Henry Widdifield farm and situated on the east side of the plank road. He and William Mandeville conducted a black-smith shop and wagon works on this site. The late Henry Oke of Union, recalled that Messrs. Jones and Mandeville built the first wagon his father bought when he started farming nearly 80 years ago.

Extracts from some of the Instruments entered on Lot number 4 in the 5th Concession of the Township of Yarmouth, namely only from the Instruments entered thereon that appear to me to mention said Lot number 4. Excepting therefrom the Instruments that mention the following Fifty acres thereof in Memorial Registration No. 3427 in Book F. for Yarmouth described in said Memorial as follows: Fifty acres and being composed of the south end of Lot number 4 in the 5th Concession of the said Township of Yarmouth.
