Hicks Home

The third home on Highway #3, west of Gordon Street was also purchased by Donald Currie in 1833 and passed to Alex Rose in 1862; then to Colin Ruthven in 1875; Samuel Matheson in 1878; John Rapelje in 1882; Edward Welch in 1899; Sydney Turville in 1904. He was a mill operator for many years. Following his death near 1936, the home was passed on to his widow, Bertha, who lived there for several years. Bertha Turville was absent from this home during the years 1937-38, caring for her elderly mother, Mrs. Thomas L. Pearce, south of Wallacetown. During this time the home was rented to the United Church minister, Rev. A. V. Walden. Mrs. Turville lived in this home during the 1940's, until sickness made it necessary for her to live with a daughter. Following Bertha's death, the home was sold in 1954 to James and Bernice Halpin. James passed away in the late 1960's, Bernice lived there a year or so, then sold it in 1970 to Frank Kicks of Windsor. His daughter, Mrs. Sharon McAllister and her three children resided with him. Mr. Hicks passed away Feb. 18, 1984.

This Lome was sold in the fall of 1985 to me and This Dwayne G. Donnelly, who reside there now. Richard & Muriel Moraal bought this home in 1987 and reside there.

Lucas Home

This is the fourth home on Highway #3 in the same area; it had also belonged to Donald Currie in 1833; then to Alex Rose in 1862; James McIntyre in 1863; Josephine Wardell in 1894; Peter Rapelje in 1898; Gideon Moyer in 1901. In 1921 Cyrus and Anna Brown moved here from their farm on the 9th Concession near the Coyne Roa d. In 1937 they sold the home to Alfred and Lottie Koehler, who had resided for many years in Tyrconnell. Mr. Koehler passed away in 1971 and Mrs. Koehler in 1979, having been a resident in Bobier Home since 1970. In 1972 the house was passed on to their son, Harry Koehler, who rented it to several couples until it was sold in 1981, to Keith Lucas of Hamilton who has been a former Dunwich boy.

A small part of these lots, had been sold around 1965 (1943) to Mrs. Ruth Bedford, who had a small home built there and she resides there now.

Small Home

The fifth older home on Highway #3, was also passed through the hands of Colonel Talbot to Donald Currie; then to Alex Rose in 1862; Adam Burwell in 1869; Colin G. Henry in 1889; Margaret Garrett in 1901; John Douglas in 1904; Mary Lucas in 1911; In 1925 John Lucas name was listed as owner, but the same year it was sold to Mary Schlindler; in 1935 it was sold to Mary Elizabeth Lindenman and upon her death to Clarence and Frances Small in 1964. Following their passing the home was purchased by a nephew, Donald and Helen Small in 1980, who have rented it to several persons since that time.

A portion of the lot facing Argyle Street was sold to George Edward Holden several years ago and he has a nice trailer home built there.

Leitch Home

This home is on the corner of Highway #3 and Pierce Street. The land was purchased from Colonel Talbot by Jeremiah Grey in 1824; sold to Wm. Pearce in 1832 and passed to John L. Pearce in 1859: Margaret Barclay was the owner in 1869 and in 1887 Charles and John Schliehauf acquired the lot. In 1892 it was purchased by James Goodall and sold in 1902 to Henry (Harry) Fox. He just lived here two years and moved to a home directly behind this house and close to the Agricultural Grounds. In 1904 Dougald and Euphemia McFarlane were the owners. The home was passed on to their daughter Annie in 1943 who continued to live there until her death. As Annie was unmarried, the estate was divided among nieces and nephews and in 1959 was purchased by Harry and Edna Scidmore of Detroit. Michigan. Mrs. Scidmore passed away in the late 1960's and Mr. Scidmore a few years later. In 1975 the home was sold to Robert and Rosemary Leitch who reside there with their two children.

Mac Webster's Home

This home is on Highway #3. just west of the Leitch home. In the very early years their homes were in the same parcel of land which Colonel Talbot had sold to Jeremiah Gray in 1824: to Wm. Pearce in 1832 and John L. Pearce in 1871. In 1880 Thomas Hubbard was the owner; followed by Archibald McLaws in 1882; John McLarty in 1886 and Annie McDowell in 1910. James Goodall was listed as the owner in 1914, but sold it the same year to John E. Whittingham. Some of the family remained there until the late 1940's. when it was left to an unmarried daughter. Nora. home was rented for a while, until it was sold to Albert and Ella Webster, retired farmers of the district, in 1952. Mr. Websterspassed paway in 1961 and Mrs. Webster in 1967. The home was then passed on to their son and his wife. Mac and Wanita Webster, as Mac was a co-owner with his parents. Renters occupied the home until 1971, when Mac and Wanita moved from their farm west of the village to this home.

John + Lynda Lamb purchased this home in 1989. They have a daughter.



David Moran's Home

This home faces Pierce Street and is adjacent to Wallacetown Fair grounds. It belonged to the parcel of land which had been transferred from Colonel Talbot in 1824 to Jeremiah Gray; in 1832 Grey sold it to Wm. Pearce and in 1859 it was passed on the John L. Pearce. He and his wife sold it in 1876 to Lauson Bowlby and then to James Goodall. In 1899 it became the property of James and Martha Pool. In 1902 it was bought by Henry (Harry) Fox and his wife Florence Lucy. Renovations, such as enlarging the upstairs and building an addition and verandah were made by the couple. Harry Fox was a brick mason and carried on his occupation in a building east of Wallacetown main corner on Highway #3. Mr. Fox passed away in 1950 and his wife Lucy continued to live there until shortly before her death in 1972. The property then passed to their daughter, Dorothy (Mrs. Edward Lamb) who sold it in 1973 to the Director, Veterans' Land Act, at which time Mr. and Mrs. David Moran and family came from Montreal to live there.

In 1984, the morand moved to St Thomas and the horne was sold to Clem Raby and wife and family. In 1986, the home was sold to Emiel and Sue Langelaan and family.



C. Armstrong Home

This property on Argyle Street belonged originally to landpurchased from Colonel Talbot by Donald Currie in 1833; Alex Rose became the owner in 1862; James Hind in 1868; Henry Cusack in 1875; Henry Clay in 1877; Wm. Hall in 1881 and then passed to Catherine Hall in 1896; In 1905 Dan P. McCallum was the owner and he and his wife Mary raised several children there. In 1926 Ellen Schindler owned the place and in 1945 it was sold to Clarence W. Taylor and then in 1950 to Chester Armstrong, who moved here with his parents Frank and Clara Armstrong from Churchville. Mr. Armstrong passed away in 1962 and Mrs. Armstrong in 1968. A daughter Viola and her husband George McArthur bought part of a lot, which faces Queen Street, from the property a few years ago and built a new home there. These homes are adjacent to the Wallacetown Fair grounds.

Norman Sutton 's Home

This property is on the south side of Argyle Street, one street south of Highway #3, and east of Gordon Street. Colonel Talbot had originally sold this land to Donald Currie in 1833 and in 1862 it passed to Alex Rose; in 1868 to Duncan McPhail; 1875 to Wm. James; 1887 to Wm. Hannigan; 1899 to David C. Clay; 1904 to Wm. C. Crehan and in 1913 to Francis W. Smith. In 1925 it was purchased by the trustees of Wallacetown United Church and used as a manse for the ministers. Rev. Dr. I.H. MacDonald was there from 1927-1937; Following Dr. MacDonald's sudden death in August 1937, Mrs. MacDonald remained until June 1938; Rev. A. V. Walden lived there from 1938-1941; Rev. Theodore Turner 1941-1943 and then Rev. Hill Hamilton until Nov. 1950, when he accepted a call to West Lorne; following this the minister lived in the manse in Dutton and served both congregations. manse was rented for 3 years to Finlay and Ethel McPherson and then sold to them in 1954. They sold the home in 1967 to Norman and Hazel Sutton and the McPherson's built a new home on adjacent property just to the east.

Morman Sutton passed away in 1988, Hazel Sutton is in a nursing home. The property was sold to David & Jo-ann Mª Vicar.

Scalia Home

Two lots to the east of the Steiner home, is another older home. This land was also purchased by Donald Currie from Colonel Talbot in 1833; sold to Alex Rose in 1855; to McLaws Brothers in 1867 and to Colin Ruthven in 1870. In 1901, John Dromgole was the owner and in 1926 Harry Dromgole. In 1928 John McFarlane purchased it. In 1946 George and Harriet Gilbert moved there from their farm near the Townline. Following the passing of the Gilberts, the home was sold to Wilbur and Estella Jacques but was sold again in 1970 to John and Florence Scalia of Coburg area who are still living here.

John Scalia passed away in November 1986.
Mrs. Flo Scalia sold the home in the fall of
1987 and moved to Beamsville. The new
owners are Kevin and Pauline Hayne, who
have one son, Geoffery.
