The Advisory Committee must be lead by a clearly identifiable individual; local and City Council's have consented to having the County CAO lead the planning process. Next steps include developing terms of reference for the Advisory and Coordinating Committees which will need to be approved by the Councils of Elgin County, Town of Aylmer, and City of St. Thomas. The plan will help streamline all of the initiatives that are already taking place in Elgin County.
