# PRESS RELEASE - ELGIN COUNTY COVID-19 FACILITIES AND SERVICES UPDATE SUNDAY, MARCH 15, 2020

Elgin County has been closely monitoring the COVID-19 situation and preparing for potential impacts to our community and workplace. The health and safety of the public and our employees is our main priority. Please be advised of the following operational changes that are effective immediately, including:

### **County Administration Building:**

• The County Administration Building is scheduled to remain open to the public at this time. Residents are encouraged to avoid all but essential trips to the County office. Whenever possible, please reach County staff by phone or email.

#### **Long Term Care:**

- The Ministry has mandated a restriction on all non-essential visits to Long Term Care Homes (Elgin Manor, Bobier Villa, Terrace Lodge);
- The Adult Day Program is cancelled until further notice.
- The Terrace Lodge pool is closed.

## **Public Libraries and Heritage Centre:**

- In keeping with guidelines from senior levels of government and in order to protect the public and our employees, all Elgin County Public Libraries and Heritage Centre are CLOSED until further notice.
- Library due dates will be extended and the Library will continue to offer a range of online tools and resources please visit the County's website or call 519-631-1460 x. 148.
- Elgin County Archives will also be closed until further notice. Staff will continue to respond to research inquiries through email at gdewaele@elgin.ca.

#### **Provincial Offences Act (POA):**

- POA Matters scheduled from Monday, March 16, 2020 through to and including Friday, April 3, 2020 will be adjourned and rescheduled to a later date. If you have a matter scheduled during this time, you do not need to attend court.
- A notice of your new court date will be sent to you by mail to the address on file with the court.
