



## STORMWATER PRIVATE DRAIN CONNECTIONS SIGNBACK FORM

PROJECT: Village of Rodney Reconstruction

LIMITS: Furnival Road (CR103) – from approximately 300m north of Centre Street to 60m north of Main Street; and,  
Queen Street (CR104) – from approximately 300m west of Flora Street to Furnival Road (CR103)

### Do you need a new stormwater Private Drain Connection?

During construction, the County of Elgin in partnership with the Municipality of West Elgin is offering to install a portion of a new stormwater private sewer – also called the private drain connection (PDC) to the property line. This type of PDC is used to manage surface flooding and/or sump pump discharge issues and may be helpful to you.

### Who installs my portion of the PDC from the property line to the building?

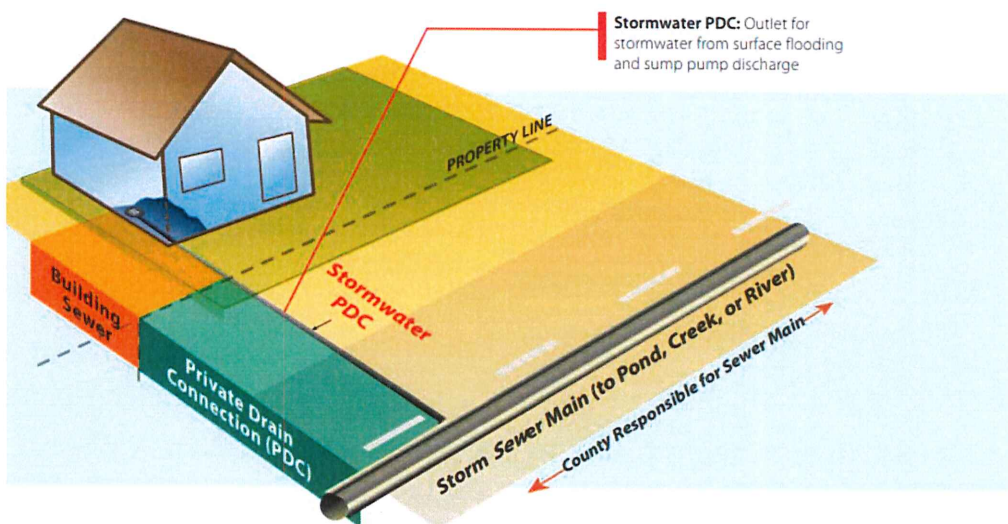
The Municipality of West Elgin will only replace the private drain connection (if required) and you are responsible to hire a qualified plumber or drainage contractor and pay for the cost of installing the building sewer portion of the pipe.

### As a property owner, you are responsible for the building sewer pipe and any PDC's

When stormwater from surface flooding and/or a sump pump is discharged and leaves your property, it flows through two sections of stormwater sewer pipe to reach the County's storm sewer (which is located under the road). The first section is known as the 'building sewer'. It flows from your house to your property line, where it meets the 'private drain connection', or PDC. The PDC is the portion of sewer which connects with the main sewer. As a property owner, you are responsible for the maintenance and repair of both of these sections of pipe.
